A MESSAGE FROM THE PRESIDENT:

The Management Committees of both **Associated Residential Parks Queensland Inc.** (ARPQ) and **Manufactured Home Owners Association Inc.** (MHOA) have agreed and resolved to recommend to their members that the two Associations should amalgamate and form one new organisation.

The rationale used in arriving at this decision is attached for your information.

To achieve this merger we have now called a **Special General Meeting** of ARPQ members on **Tuesday 13**th **December 2022** to approve the following:-

- 1. Pass a motion agreeing to the proposed merger
- 2. Agree to a name for the new Association.
- 3. Agree on a constitution for the new entity subject to approval by the Office of Fair Trading
- 4. Elect an Interim Committee to manage the new Association until such time as a duly elected Committee can be formed

RATIONALE:

In support of the decision of your Management Committee to propose to the ARPQ membership the notion that we should amalgamate with the MHOA, we provide for your information the following rationale and reasons underpinning this decision.

- Provide a greater depth of experience and knowledge to allow more timely advice and support to Members requiring assistance; and
- New and innovative ideas for advocacy for the betterment of home owners and legislated consumer protections.
- Provide a larger pool of human resources to carry out the important work currently performed by both Associations.

THE PROPOSED CONSTITUTION:

The proposed Constitution has been developed by modifying the Model Rules set out by the Queensland Government, to suit the particular needs of an organisation developed to assist Manufactured Home Owners living in Residential Parks. Because it is somewhat lengthy, it cannot be attached to copies of this notice. It is however available for viewing on the ARPQ Website (https://arpq.org.au) or a copy will be emailed or posted to members by the Secretary upon request.

WHAT HAPPENS NEXT?

If Members of both associations agree to the merger of the two associations, then:

- a) An application to amalgamate is lodged with the Office of Fair Trading
- b) This will contain the suggested name of the new association, the suggested Constitution and the names of the elected Officers.
- c) If amalgamation is approved by the OFT, the Interim Committee, consisting of all current members of both associations' committees, will complete the amalgamation process by combining the present duplication of services into single services for the new association. These will consist of:
 - A single bank account
 - A single new Website
 - A single register of members
 - A single Advice and Assistance Service
 - A single stronger advocacy voice in dealings with Government and other stakeholders.
